Representative Experience

Ms. Sarmentero has represented clients on various rate proceedings initiated pursuant to Section 4 and Section 5 of the Natural Gas Act. She successfully represented a client in litigation to reduce the Return on Equity of transmission utilities in the MISO region resulting in multi-million dollar reductions in wholesale electric rates. Ms. Sarmentero also negotiated and prepared documentation to transfer operational control of transmission facilities to the CAISO and to PJM Interconnection.

Prior to joining JSS, Ms. Sarmentero worked at the New Jersey Board of Public Utilities' Counsel Office where she gained a good understanding of public utilities' businesses and regulatory compliance obligations at the state and federal levels. When at the New Jersey Board, Ms. Sarmentero was heavily involved in regulatory activities at NARUC and OPSI. As part of her work with NARUC International, she went to Kosovo to help energy regulators resolve electric market design issues while ensuring compliance with EU legislation. Ms. Sarmentero also worked with the World Bank in an electricity restructuring research project seeking to understand regulatory investment risks in Eastern Europe. Ms. Sarmentero has extensive energy regulatory and transactional experience in Europe where she worked at the Council of European Energy Regulators, COGEN Europe and at the Council of the European Union on matters concerning approval and implementation of EU energy legislation, including the Third Energy Package.
